## HEREFORDSHIRE COUNCIL (LEDBURY ROAD & THREE CROSSES ROAD, ROSS-ON-WYE) (PROHIBITION OF WAITING AT ANY TIME) ORDER 2024

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Sections 1, 2 & 3 of Part 1 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, and of all other enabling powers make the above Order, the general effect of which will be to introduce:

**No Waiting at Any Time (Double Yellow Line) restrictions on the following lengths of road: Ledbury Road (Western Side)** From its junction with Three Crosses Road for a distance of 13m in a south-westerly direction. From its junction with Three Crosses Road for a distance of 16m in a north-easterly direction.

Ledbury Road (Eastern Side) From the southern property boundary of Kingstone for a distance of 48m in a north-easterly direction. Three Crosses Road (Southern Side) From its junction with Ledbury Road for a distance of 10m in a north-westerly direction. Three Crosses Road (Northern Side) From its junction with Ledbury Road for a distance of 31m in a north-westerly direction. Three Crosses Road (South-Eastern Side) From the southern property boundary of No 75, Three Crosses Road for a distance of 12m in a north-easterly direction. This Order will come into effect on 25<sup>th</sup> March 2024.

Any representations received by the Council may be imparted to third parties. We will keep your data for up to 7 years. Your information may be shared with other Balfour Beatty teams within Herefordshire and Herefordshire Council in order to provide you with the service.
