All-Age Joint Autism Strategy Update: Glen Crosier / Valerie Fitch

Glen discussed how Cabinet had approved the Autism Strategy and the Strategy will now be presented to the Health and Wellbeing Board. The design team is currently making finishing touches to the Autism Strategy including implementing the changes requested by Board members at the sign off meeting on November 28th last year.

Action 1 - Valerie will send the finalised Autism Strategy, when available to Paul, he will forward to Board members.

Making Every Adult Matter (MEAM) Katie Labbett – Herefordshire Council

Katie was unable to attend.

Action 2 – Paul to add to the next agenda.

Partnership for Inclusion of Neurodiversity in Schools (PINS) - Anna Swift – Integrated Care Board (ICB)

Anna explained the funding was to support the neurodivergent pupils in 36 primary schools across Herefordshire. The funding will enable schools to have a suite of support available to them. The schools on board will each complete a self-assessment tool to identify what is being done well and what needs to be improved. A £1000 has been allocated per school for support provision. Additionally a suite of support will be put together by the ICB that can provide multiple schools with support from the steering group and the therapy team, the specialist teacher locally or purchased.

Between now and September support needs will be identified and decisions on how those needs can be met will be made. The support will then be implemented between September to July school year.

Parent Carer Voice will provide support to the schools to help identify the support needed. They hope mentors can share learning with other schools across Herefordshire and Worcestershire.

A steering group has been set up to identify what support is needed. The group includes:

- Hilary Jones (Head of Service / Service Manager Additional Needs)
- Debbie Hobbs (Parent Carer Voice)
- Elizabeth Kearns (Head Teacher, Hampton Dene Primary School)
- Della, Pascoe (Early Years SEND Inclusion Service Manager)
- Representatives from NHS Therapy Teams
- Representatives from CoSI Social Interaction Services and leads from the ICB.

Monthly meetings have been booked in until next April.

Regarding the governance structure, the steering group will report to the Children's and Young People Delivery Group who will report to the Learning Disabilities and Autism Assurance Board which is led by Jack Caine and Richard Keble.

Anna expressed her desire to get young people involved in giving feedback on the project. James suggested that Anna link in with the Youth Provision Board run by HVOSS.

Action 3 - James will share the contact information with Anna after the meeting.

Police Hate Crimes reports (Themes) - Valerie Fitch

Valerie hadn't received the Hate Crime Reports from the Police to share with the Board.

ICS updates - Anna Swift – Integrated Care Board/Valerie Fitch

Anna went through the latest updates from the ICB including: Annual Health Checks, Sensory Friendly Environments, Reasonable Adjustment Digital Flags (RADF), Review – Accessibility of

Mental Health Services Autistic for People and Neurodivergent Children & Young People's Programme. Please see attached.

Anna mentioned that Jack Caine is leading on the Sensory Friendly Environments in Herefordshire taking over from Richard Keble.

Laura said she would share some links to national research on supporting people and their families pre-diagnosis from Autistic and ADASS with Anna.

Valerie mentioned that her son was in one of the videos made by Taurus Healthcare on patients going to have their annual reviews. Valerie along with her son will be attending the ICB meeting next week where the video might be shown, If anyone would like to have the link to the video please email her.

Landline Digital Switch Over Concerns - Dave Andrews (Senior Telecare Advisor, Community Wellbeing) Technology Enabled Care/Technology Enabled Living.

Dave mentioned that there were over 2,000 people across Herefordshire using telecare provided by the Council. Telecare is an impendent alarm and equipment that when triggered send a signal to a base unit which subsequently calls a call centre who respond to that trigger.

Dave explained that the big issue is the switch from an analogue telephone system to digital. He explained on switching to digital telephone service including the loss of connectivity in the event of a power cut compared to analogue without new equipment being installed.

A programme of work is underway to change over every single piece of telecare equipment provided over the past 20 years to a newer digital form that will work when the digital switch takes place. BT Openreach have been tasked with having everyone switched over to fibre optic lines by the end of 2025. He further discussed the issues around the need to replace the older copper cabling with higher bandwidth fibre optic cabling, installing new telecare equipment capable of using the cellular network in times of power cuts or broadband issues and the need to have more of Herefordshire covered by the mobile networks.

Dave also mentioned that charges will be increased to accommodate the added costs. Individuals with telecare equipment should notify their call provider that they are a vulnerable person and therefore should not be changed over to digital without consultation.

A newsletter is being worked on which will be sent out shorty to explain the situation to those affected, a digital version of this newsletter will be shared in due course, it will also be available via the Council's website.

Sylvia asked for letters quoting the increased telecare rates to be based on the monthly cost in line with their billing by Hoople rather than the current weekly basis.

Autism assessments - some challenges and recent findings (high functioning girls) - Laura Ferguson/James Baker

James explained how Laura and he had supported a young lady from Hereford Make to have an additional assessment and get an autism diagnosis. Laura and James co-wrote a letter detailing high level of knowledge of the diagnostic process, some mitigating factors and issues with the original assessment. James and Laura highlighted some of the learning from the original assessments and the reasonable adjustments that helped the lady finally get an autism diagnosis. Issues highlighted included:

- Originally not being offered an assessment locally. This decision caused undue stress compromising the original assessment.
- Masking by the individual not being picked up. Issues that led to masking included: the
 effects of medication not being taken into account, not being offered a quite space and the
 presence and bias of the individual's mother who did not want her daughter to be
 diagnosed
- The lack of advocacy support- Individuals should be able to bring their own chosen advocate with them to the assessment or be offered one. Their advocate shouldn't have to be a family member.

James also explained how, due the lady's complex needs, the previous assessors hadn't gone into separating what was behaviour due to OCD and behaviour due to being autistic partly down to the masking at the previous assessment.

Laura and James discussed how as a Board we need to look at how organisations can support people following an unsuccessful autism diagnosis including challenging the result of an assessment. Laura also mentioned how the ICB as commissioner could really benefit from having more feedback on people's experiences of the diagnostic process (particularly from those on the fringes).

Valerie also mentioned the work we all need to do on challenging people's negative perception of being autistic.

Action 5 - Laura and James agreed to share the learning as a case study with Anna.

Anna mentioned the ICB is planning to commission a service specifically for children and young people aged 0-18 to support their needs relating to getting a diagnostic assessment and mental health provision. The service will also have better transitional arrangements into the adult assessment space.

The ICB is also look at developing a support service for children and young people. The ICB is currently mapping what support is currently available and what additional support is needed. Anna invited Laura to be part of this process. The ICB is also looking to work with Autism West Midlands to improve the range of advocacy support available.

Valerie asked Zoe Bristow to give a brief overview of the courses Autism West Midlands run.

Zoe gave a brief overview of the courses Autism West Midlands currently offers, this includes:

• 1:1 Information, Advice and Guidance Sessions. A series of 4 person-centred sessions with one of their autism advisors.

- Autism Confident Programme -This is a free 8-week programme which aims to help individuals understand more about autism, improve their confidence, and provide an opportunity for individuals to meet other autistic people. It also offers opportunities for individuals to develop their social skills in a supported group setting.
- *Teen Autism Confident Programme.* This programme was launched this year in Herefordshire and is for individuals age 13-17 years old. The programme is open to teenagers with an autism diagnoses.

Teens Autism Confident Course and update - Zoe Bristow Autism Westmidlands

Zoe mentioned that from the three *Teen Autism Confident Programme* sessions that have occurred feedback from parents is the lack of understanding of autism within Schools. Students were particularly having problems managing their sensory overload needs in school as they would at home. An example of this was teachers not always allowing the use of fiddle items in class.

Zoe also asked members on the Board to help fill in a *Co-Production Survey* on what social groups, peer groups and support groups would be beneficial to autistic adults in Herefordshire. James suggested Zoe send the survey to the colleges to get student feedback.

Action 6 - Valerie asked Zoe to forward information on these Autism Confident Programmes to Paul so it could be shared with Board members.

b) Hereford Disability United

Sylvia noted that during a Mental Health Partnership Event for people up to the age of 30 one of the speakers used a phrase in her discussion saying "There appears to be an epidemic of autism" which some in the autistic community thought it related to meaning autism is infectious like a disease, while some professionals and practitioners thought it referred to false diagnosis taking up resources.

Subsequently Sylvia and the speaker in question both sent out a letter of apology to everyone that attended regarding no offence had meant to be caused by the phrase "epidemic of autism".

Following on from this Silvia has been contacted by the Herefordshire and Worcestershire Wellbeing Recovery College that is concerned with mental health and how to approach it. After discussing the incident they decided it would be beneficial to get a better understanding of how people interpret language.

Silvia is therefore going to set up a group through the Making It Real Board to look at developing a video course on how people interpret language. The group will be meeting at the Aspire Hub on Tuesday the 21st May from 12-2pm, anyone is welcome to attend.

Dr Marisa Lewis introduced herself, explaining she is a psychologist working in independent practise in Hereford. She explained how she has worked with autistic individuals, children and adults, for 17 years assessing, diagnosing and providing psychotherapeutic support. This included years of experience working in the NHS and Welsh Government on developing autism services and within the assessment process.

Dr Lewis explained her desire to network and find out what services were available in Herefordshire for her clients and the families she is working with. She also wanted to know the current position within health, social care and education regarding independent providers providing assessments.
