1. Update on EA led schemes

• Catchment Based Group (CBG)

- **Leominster** (EP) Parallel environment project currently progressing which comprises remodelling a section of River Lugg, the outputs of which can be fed into this project.
- Lower Bullingham (JH/EP) Site visit undertaken with HC/BBLP/EA. Flooding mechanism established. Farm access culvert requires improvements.
- Ewyas Harold / Dulas Brook (EP) Model has been updated. Likely to be Property Flood Resilience (PFR) project.
- River Dore (Pontrilas) (EP) Has been established as a separate project to Ewyas Harold.
- River Arrow Lugg and Arrow Weir Impact Assessments (EP) First deliverables have been received.
- **River Arrow Lugg and Arrow Asset Management Review** (EP) Progressing along with Lugg & Arrow Weir Impact Assessment.
- Hampton Bishop (EP) Penstock installation proposed in ditch system. Still awaiting outputs from River Wye & River Lugg models.
- **Eardisland** (EP) PFR project still progressing following flooding in January. Followed up on Listed Building queries.
- **Mordiford Bridge** (EP) Asset Performance Team are leading on project and are looking into emergency action plans when flooding occurs.
- **Greyfriars** (JM on behalf of Tom Curwell) Ground investigation surveys are being undertaken. Assessment ongoing of how Yazor Brook will continue to flow through defences.
- Leintwardine and Walford PFR (EP on behalf of Sam Whitfield) The Business Case has been signed off and PFR contractor has been appointed. Installation to start beginning of April and complete end of Summer.
- Bishops Frome PFR (EP on behalf of TC) To be looked at in 2024. Likely to be PFR.
- Cusop/Dulas Brook (EP on behalf of TC) Funding process started for installation of resilience measures.
- Ross on Wye (EP) No update, awaiting outputs from River Wye model (expected 2025).

2. Update on HC led schemes

- Ayles Brook Surface Water Mapping (JA) Model outputs are due to be submitted to EA within the next week.
- Brimfield, Orleton and Little Hereford PFR (JA) Contractor has undertaken surveys.
- Coughton Brook (JH) No update
- Kymin Brook (JH) Grant application for project funding to be progressed in 2024/25.
- Lyde (JH) The Herefordshire Council Land and Property department negotiations with the landowners are ongoing.
- Wellington Brook (JH) Optioneering using the model will be completed in Spring 2024.
- Yazor Brook Culverts (JA) FCERM7 has been drafted.
- Eardisley (JH) Scope of works and project proposal being developed.
- Withy Brook (JH) As the EA are leading on a Catchment Based Assessment (Lower Bullingham), there is no update.

• Hoarwithy (JA) – Draft OBC has been submitted to EA.

- **River Lugg Embargo** (SH) EP to update following internal discussions (clearance works on River Lugg).
- Aston Ingham (JH) Reports regarding presence of stone wall on flooding have been discussed with EA. Response to be communicated with community.
