SERVICE OVERVIEW

SERVICE SUMMARY

Balfour Beatty Living Places (BBLP) will manage Herefordshire's Parks, Open Spaces, Landscaping, Verges and Trees to ensure the Public Realm is accessible, safe, clean and well-maintained. Core grounds maintenance related services include; Grass Cutting and Maintenance, Arboriculture Maintenance (including tree surveys), Chemical Applications, Bereavement Services (Cemeteries Maintenance and Grave Digging) & Playgrounds.
