# **Matters Arising**

**Action 1-** Member raised that they had not received an update on the staff restructure within adult social care. Paul will chase with Zakia.

# Family Carer Representation on the Board

Rose raised concerns on the lack of family carer representation on the board. Paul will contact Nick Greggery from Carer Links to see if he has had any interest from parents interested in being involved in the board.

**Action 2** -Manny suggested that the board should have an action log that can continuously updated. Paul and Laura will create this.

# Signing off Board documents

Tracy requested that minutes and other documents relating to the board that need signing off include a space or section for her as chair to sign. From now on Paul will add a section that Tracy can sign either electronically or in pen.

# Update on the LD Strategy Refresh Work

Manny discussed the work already ongoing in preparation for either a new Learning Disability Strategy or refresh of the current one. This included looking at what outcomes in LD Strategy Implementation Plan that have been completed by Herefordshire Council. Feedback on the strategy will be sort from providers, NHS, service users and families, to then be worked through by the Learning Disability Strategy Working group. This will then be collated together, and a summary will be provided to the Learning Disability Partnership Board in due course.

While Manny was discussing the work undertaken, she highlighted the following points:

#### The accommodation and care at home strategy.

- Shared Lives is planning to do daytime respite.
- The new Transitions policy. Manny asked this to be shared with the group alongside the minutes.
- Complex needs Service- Manny discussed the proposal for new care facilities
  for adults and children with complex needs, and that the council was looking
  to set up a working group to discuss. She emphasized the importance of
  getting the opinion of ICB colleagues, carers, residents and providers on what
  long term residential or supported accommodation facilities are needed in
  county. A business case is being developed to secure funding for the creation
  of these new care facilities
- Mark Bywater has been appointed as the TEC Team Manager. He is currently looking at producing training modules to educate the social care workforce on the assistive technology solutions. Assistive technology is being embedded in discharge planning processes to ensure individuals can return home safely with the right support
- An Interactive tool for equipment demonstrations in a 3D virtual home is available. A link will be shared with the board.

Information about the Care Providers and Housing Options including the links to virtual home, technology and living aids <u>can be found on the Government website</u>.

**Action 3-**Manny said she would invite Mark to a future board meeting to discuss assistive technology.

**Action 4-**Paul to send out the transition policy with the minutes.

Laura highlighted that the Allocation policy was being updated, and the strategic housing team are planning on creating an easy read version by the end of May. Laura hopes for an update by the June meeting.

Chris raised concerns around the potential negative impact of grouping individuals with similar complex behaviours together, and the need for careful planning to avoid exacerbating these behaviours.

**Action 5-**Manny said she would have Chris invited to any future working groups regarding the accommodation needs for people with complex needs.

In answering some questions from Mike Manny reported that the market position statement is being updated this year, and the transition numbers will be included in it.

The Council is also creating an Accommodation and Care at Home Strategy which will also include transition data and will model the future accommodation provision needed over the coming years.

#### **Aging Carers**

The action plan for aging carers that's part of the Carers Strategy will be going to the Scrutiny Committee on the 31st of March 2025.

#### **Carers Partnership Board**

The Carers Partnership Board has been set up and has had a few meetings. It is looking to ratify the Carers action plan.

The Carers Partnership Board has set up a subgroup for young carers to attend and raise issues. A representative will then feedback these issues to the main board. The board has come up with a set of actions for this year.

Young carers subgroup will be focusing on:

- 1. Promoting young carers passports,
- 2. Encouraging schools to promote a young carers champion,
- 3. Reviewing assessment processes and availability of assessments,
- 4. Reviewing and updating information
- 5. Supporting and promoting NHS careers.

Manny asked members for their views whether they would like to be kept up to date on the work of the Carers Partnership Board. Members agreed they would like to be kept up to date on work and issues that relates to learning disabilities.

# Potential for a Joint Learning Disability Strategy.

Manny mentioned Worcestershire's Learning Disability Strategy runs till the same time as Herefordshire's LD strategy in 2028. This gives the potential option for both counties and board to produce a joint strategy.

#### Updates on Vice Chair recruitment and visit to the National Star College

Paul, Laura and Tracy visited the Nato National Star College and spoke to students about becoming involved in the board and potentially applying for the role of Vice chair

They are planning to visit Aspire, Envirobility and Hear Our Voices to promote board engagement and the vice chair position further in the coming weeks.

Laura has shared information about the board and vice chair role with Andy from the National Star College, alongside the LD Strategy in the hope of getting the views from residents outside of Herefordshire

# Updates from the February Joint Learning Disability Partnership Board Meeting

Tracy and Mike have a brief overview of the agenda items discussed at the Joint LDPB meeting on the 11<sup>th</sup> of February. The theme of the meeting was around health and community safety.

Highlights included Health checkers discussed the work they were doing in conjunction with a new priority action group around promoting healthier lifestyles and their visit to Kidderminster to access the day services ward. Cat Bennit from Our Way and Tracy discussed the Safe Places schemes in both counties. Matt Cole discussed Community Safety and I Am Me project including how to report abuse and hate crimes.

#### **Bus Passes**

Rose discussed how Mencap had been campaigning for the 9:30am start between Monday and Friday for bus passes to be abandoned. They attended a Council

meeting on Friday to raise the issue and their campaign will be discussed further at another cabinet meeting. Ellie Chowns the MP for North Herefordshire has been endorsing their campaign and hopes that it becomes a national policy by raising it in Parliament.

All day use of bus passes has now been approved in Cambridgeshire and Peterborough and are due to come into effect this May. All day bus passes are already in effect in Norfolk and South Yorkshire.
