NOTICE OF PUBLIC PATH ORDER

HIGHWAYS ACT 1980 SECTION 119

**HEREFORDSHIRE COUNCIL
PUBLIC FOOTPATH SL2 (PART) STOKE LACY
PUBLIC PATH DIVERSION ORDER 2025**

The above order made on 6th June, 2025 under Section 119 of the Highways Act 1980 will divert that length of Footpath SL2 (Part) in the Parish of Stoke Lacy which commences at OS Grid Reference SO 6152 5006 (point A on the order plan) and proceeds in a generally southerly direction for approximately 58 metres to OS Grid Reference SO 6154 5000 (point B on the order plan). It turns in a generally east north-easterly direction and, crossing the River Lodon, continues for approximately 49 metres to OS Grid Reference SO 6158 5002 (point C on the order plan). The total length of the existing said footpath is approximately 107 metres.

An alternative footpath will be created, being 2 metres in width, which commences at OS Grid Reference SO 6152 5006 (point A on the order plan) and proceeds over a concrete farm bridge across the River Lodon in a generally east north-easterly direction then in a generally east south-easterly direction for approximately 48 metres to a footbridge at OS Grid Reference SO 6157 5005 (point D on the order plan). It continues in an easterly then southerly direction for approximately 33 metres to OS Grid Reference SO 6158 5002 (point C on the order plan). The total length of the said proposed new footpath is approximately 81 metres.
