1.0 Introduction

- 1.1 Planning Policy for Traveller Sites (PPTS) 2023 sets out the Government's planning policy for Traveller sites. It should be read in conjunction with the National Planning Policy Framework (NPPF).
- 1.2 Paragraph 10 of PPTS states that local planning authorities (LPAs) should, in producing their local plan, identify and update annually a supply of specific deliverable sites sufficient to provide five years' worth of sites against their locally set targets.
- 1.3 This report sets out the five-year supply position in Herefordshire for Gypsy, Traveller and Travelling Showpeople at 31 March 2025.

2.0 Context

- 2.1 Current and future need for Gypsy, Traveller and Travelling Showpeople accommodation in Herefordshire is documented in the <u>Herefordshire Gypsy, Traveller and Travelling Showpeople Accommodation Assessment 2022 (GTAA)</u>. The GTAA separates out the pitch and plot requirements for Gypsies and Travellers, and Travelling Showpeople as the two groups have different site requirements.
- 2.2 In relation to new Gypsy and Traveller pitch requirements, the assessment provides two sets of figures: first, a needs figure based on ethnic identity; and second, a figure based on the definition included in the Government's Planning Policy for Traveller Sites (PPTS) (2015) guidance which was the relevant guidance at the time.
- 2.3 However, in December 2023, the Government has revised the <u>Planning Policy for Traveller Sites</u> by reverting the definition of gypsies and travellers broadly back to its original definition in the PPTS 2012. It now states 'Persons of nomadic habit of life whatever their race or origin, including such persons who on grounds only of their own or their family's or dependants' educational or health needs or old age have ceased to travel temporarily or permanently, but excluding members of an organised group of travelling showpeople or circus people travelling together as such'. (PPTS, Annex 1: Glossary).
- 2.4 This amendment reintroduces the reference to those who have ceased to travel **permanently** due to education, ill heath, or old age. It remains the case, however, that

to meet the definition households must have previously travelled for work or seeking work, regardless of whether travelling has ceased on a temporary or permanent basis.

- 2.3 Due to this change in definition, the ethnic definition need has been used when calculating the five-year supply.
- 2.4 The GTAA provides one need figure for Travelling Showpeople to reflect the PPTS definition which has remained unchanged.

3.0 Conclusion

- As at 31 March 2025, there is 0 years supply of deliverable land for Gypsy and Traveller pitches. (0/1.4 = 0). There is a shortfall of 7 pitches over the next 5 years.
- 3.1 As at 31 March 2025, there is 0 years supply of deliverable land for Travelling Showpeople plots. (0/0.6 = 0), There is a shortfall of 3 plots over the next 5 years.

- 4 pitches at Oakfield, Nash End Lane, Ledbury (P183661/F)

- 19 pitches at Land at Madley Caravan Site, Madley (P242363/F)
