Granite Woodland Tree Vaults and Memorial Tablets are made from polished granite.

These vault memorials are for two sets of cremated remains, with a single granite memorial tablet in gilded lettering fitted onto each section in memory of the deceased. Alternatively, one double granite memorial tablet in gilded lettering can be fitted which covers both sections of your chosen memorial.

There are two double granite vaults for each tree.

These memorial tablets are placed on the memorial vaults for an initial 30 year period. The lease is available for renewal at any time. Tree vault memorials can be reserved for future use if required (subject to the payment of the lease). Please be aware that if the lease is not renewed the cremated remains will be removed from the vault and scattered on the lawns of the Garden of Reflection, the memorial tablet(s) will be removed and disposed of and this memorial vault will be made available for future use.

Granite memorial tablets are ordered on an individual basis and take approximately 6 – 8 weeks.

The lease will commence on the day the tablet has been fitted or with the interment of the cremated remains.

(REQUESTS TO PLACE MEMORIAL VASES BELOW THESE TREE VAULTS WILL BE DECLINED)

NO MORE than ONE LETTER or NUMBER must be written in each box DO NOT FORGET TO INCLUDE SPACES IN YOUR INSCRIPTION. A space counts as a letter
