STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

1 (landowner) TREVOR KEITH BROWN DO SOLEMNLY AND SINCERELY DECLARE as follows:

I am and have been since (day, month, year) MARCH 1989 the owner of the land known as (name of farm, etc) land adjoining May Tree Cottage Hande Hill Ross-on-Wye more particularly delineated on the plan accompanying this declaration and thereon edged red, and hatched black

2. On the (day) day of (month, year) I (or my predecessor in title (name)) deposited with the County of Herefordshire District Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that [the ways coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as highways with vehicular status], [the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways]; [the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths]; [no [other] ways had been dedicated as highways over my property].

3* On the (day) day of (month, year) I (or my predecessor in title (name)) deposited with the County of Herefordshire District Council, being the appropriate Council, a statutory declaration dated (day, month, year) stating that no additional ways [other than those marked in the appropriate colour on the plan accompanying this declaration] had been dedicated as [highways with vehicular status] [bridleways] [footpaths] since the deposit of the Statement referred to in 2 above.

4.** No ~~additional~~ ways have been dedicated over the land edged red and hatched black on the plan accompanying this declaration since the statement dated (day, month, year) referred to in 2 above [since the date of the statutory declaration referred to in 3 above] [other than those (highways with vehicular status) (bridleways) (footpaths) marked in the appropriate colour on the plan accompanying this declaration] during my ownership of the land

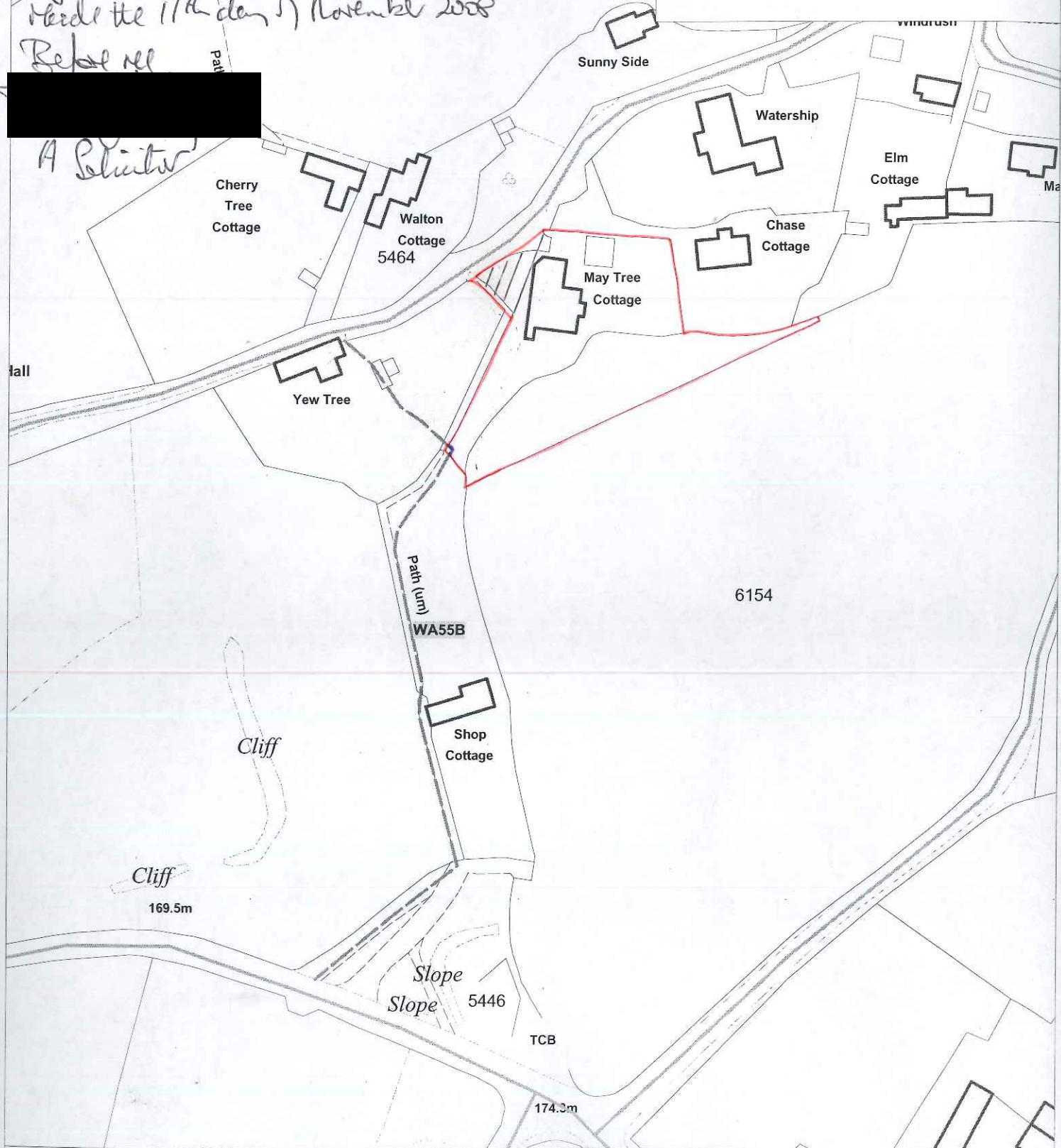
