

STATUTORY DECLARATION

HIGHWAYS ACT 1980 SECTION 31 (6)

- 1. AND I MAKE this solemn declaration on the .s. day of December, 1997 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.






I SARAH PRIESTMAN DO SOLEMNLY AND SINCERELY DECLARE as follows:
