I Rebecca Anne Goodwin DO SOLEMNLY AND SINCERELY DECLARE as follows:

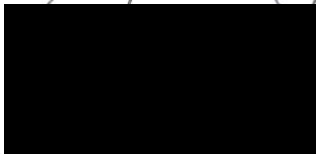

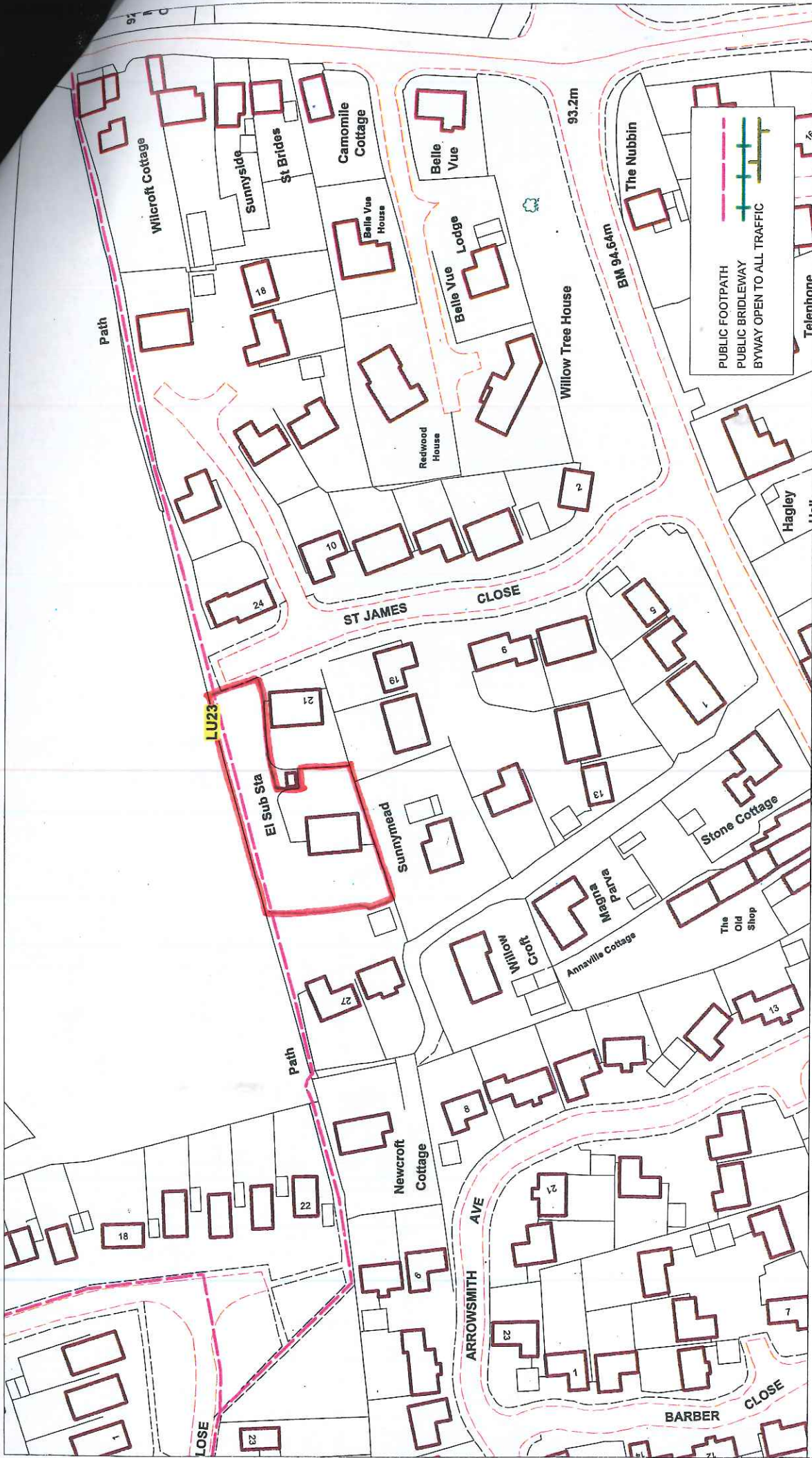
