



STATUTORY DECLARATION  
SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) WENDY ELIZABETH VICE DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since (day, month, year) 1<sup>st</sup> NOVEMBER, 2004 the owner of the land known as (name of farm, etc) THE PARK, WOOLHOPE, HEREFORDSHIRE more particularly delineated on the plan accompanying this declaration and thereon edged red.
