




## STATEMENT PURSUANT TO SECTION 31(6) HIGHWAYS ACT 1980

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (la	ndowner) JOHN ALEXANDER WATSON DO SOLEMNLY AND SINCERELY DECLARE as follows:
