STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (Jandowner) BRIAN PHILLIP PRICEDO SOLEMNLY AND SINCERELY DECLARE as follows:

- 1. I am and have been since (day, month, year) MARCH 1990 the owner of the land known as (name of farm, etc) HOLMER HOWSE FARM HOLMER HRY9RG more particularly delineated on the plan accompanying this declaration and thereon edged red.
- 2. On the (day) 12 JUNE 2009 day of (month, year) BPTAN P. PRICE I (or my predecessor in title (name) IOP TOP STOPE CE.) deposited with the County of Herefordshire District Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that [the ways coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as highways with vehicular status], [the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as highways]; [the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths]; [no [other] ways had been dedicated as highways over my property].
- 3.* On the (day) 12 JUNE day of (month, year) 2009 I (or my predecessor in title (name) 10.PXOE PRICE) deposited with the County of Herefordshire District Council, being the appropriate Council, a statutory declaration dated (day, month, year) 12 JUNE 2009 stating that no additional ways [other than those marked in the appropriate colour on the plan accompanying this declaration] had been dedicated as [highways with vehicular status] [bridleways] [footpaths] since the deposit of the Statement referred to in 2 above.

4.** No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated (*day, month, year*) referred to in 2 above [since the date of the statutory declaration referred to in 3 above] [other than those (highways with vehicular status) (bridleways) (footpaths) marked in the appropriate colour on the plan accompanying this declaration]
