P3: As part of the new Public Realm contract, the P3 scheme has been reviewed, revised and extended and is now part of the wider revamped Lengthsman scheme which enables and encourages self-help by Parish Councils in resolving highways maintenance issues. Under the new model, 114 parishes have registered an interest in taking part in P3 in 2015-16, covering 2820km of PROW. Parishes are required to prepare a brief annual plan identifying routine works and improvement projects they wish to carry out and will be able to claim grant money quarterly in arrears. The new scheme will be monitored to evaluate take up and effectiveness.

Notices served on Herefordshire Council - Section 56 & 130 Highways Act 1980

During this period one S130A notice was served on HC alleging obstruction of path LR13 (Ledbury Rural). Following receipt of this notice Form 2 was served on the person responsible for obstruction and Form 3 was served on the person serving notice on council. A lock on a field gate was subsequently removed by a landowner, and overgrowth and up-growth has largely been removed.

Three S56 notices have been served on HC with all responded to within statutory time limits -

- 2. LX2, Leintwardine parts of path lost to river erosion. Ongoing work with landowner with regard to diversion
