What are the options?

Holmer West

Three Elms

Holmer Ea

Holmer West

Around 1,000 new homes (35% affordable) are proposed. The growth will be reliant on bus priority and new walking and cycling routes to access the city. There is also scope for Park and Ride, a new primary school and new community facilities.

Holmer East

Land at Holmer East is proposed for employment development (5 hectares). This will balance the significant employment opportunities at Rotherwas Industrial Estate and complement those proposed to the west of the Hereford Relief Road in association with the new livestock market

Three Elms

Around 1,000 new homes (35% affordable) are proposed. The provision of additional 10 hectares of employment land at this location will balance that at Rotherwas. A western Park & Ride and new cycle and pedestrian links are planned as part of a package of transport measures aimed at discouraging car use.

City Centre

The development of Hereford city centre up to 2026 will seek to achieve the overall regeneration of the historic heart of the city and the expansion of its central area to the west and north. This will be achieved through. amongst other things, the provision of 800 homes in a new urban village, additional shops and leisure facilities. Overarching all future proposals is the need to ensure the protection and enhancement of the historic retail core and Hereford's historic heritage and character.

(35% affordable) are proposed. There is scope for extending the capacity of Whitecross High School and Specialist Sports College and also providing a new primary school. A neighbourhood community hub will provide a range of facilities from retail to health care. New cycle and pedestrian links will reduce private car use.

Lower Bullingham

Around 1,000 new homes (35% affordable) will be provided, to be accessed via the Rotherwas Access Road. A southern Park & Ride site is proposed in the vicinity of the A49/Rotherwas Access Road roundabout to complement those proposed to the north and west of the city. The provision of a neighbourhood community hub will provide for a range of local services. Employment will continue to be focused on Rotherwas Industrial Estate.

Western relief road

A western corridor is proposed for the Relief Road, as part of an overall transport package to address movement in and around Hereford and enable sustainable transport choices where possible. The proposed corridor is linked to growth and avoids key environmental interests to the east. The precise route of the road will be defined in the forthcoming Hereford Area Plan

Common Themes

Rotherwas

A network of green infrastructure is planned within all expansion areas. Linear green routes which can be used for biodiversity and conservation, together with sustainable transport routes and leisure and flood management will be incorporated into developments on the city's peripheries.

Relief road options considered

The Council has undertaken a thorough assessment of options for the relief road corridor, to both the east and west of the city. This has highlighted the environmental interests associated with the Lugg Meadows to the east, notably a Site of Special Scientific Interest and a Special Area of Conservation, as well as other designations. The preferred choice of route to the west not only avoids these features, but is also linked to the main growth areas proposed to the north

Importance of growth

Growth in Hereford will enable some important issues to be addressed including the imbalance in housing stock, need for affordable housing, limited employment and education opportunities, restricted retail choice and traffic congestion. The Place Shaping Paper indicated that 78% of people were in favour of the growth strategy for Hereford. Limiting this growth will affect the ability to address these social and economic issues.
