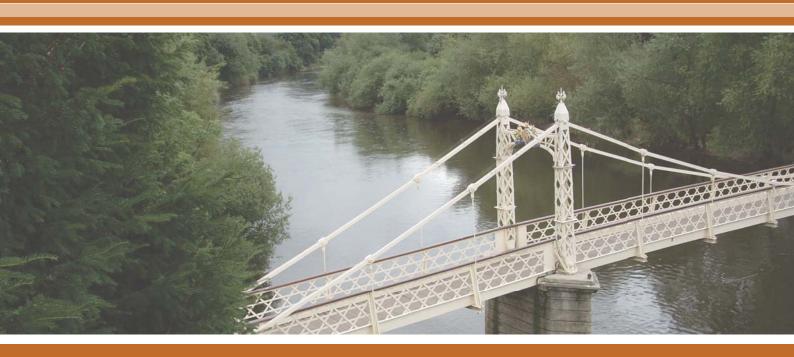

Appendix 2: Feedback on Habitat Regulation Assessment (HRA) Report consultation

#### 1.0 Introduction

1.1 To ensure that the requirements of the Habitats Directive and Regulations are met, it is necessary to consider the proposed amendments through the HRA process to the Eardisland NDP; the NDP was refined by the NDP steering group to reflect feedback from consultation on the Draft Plan and Draft Environmental and Habitat Regulations Assessment (HRA) Reports, refer to Appendix 2.

- 1.2 The purpose of this further HRA Addendum Report is to detail the findings of the screening of proposed changes to policies and consider if they significantly affect the conclusions of the earlier HRA Report (November 2015).
- 1.3 The majority of refinements are not considered to significantly affect the conclusions of the earlier HRA report as many were points of clarification. However there were no changes to the overall aims and direction of the existing planning policies.

#### 2.0 Screening of draft NDP

- 2.1 Regulation 102 of the Habitats Regulations 2010 requires that a Screening Assessment be undertaken, in order to identify the 'likely significant effects' of an NDP. Accordingly, a screening matrix was prepared and this determined the extent to which any of the policies within the Eardisland NDP would be likely to have a significant effect on the River Wye SAC.
- 2.2 The findings of the screening matrix can be found in Appendices 1 and 2 of that report.
- 2.3 The screening matrix took the approach of screening each policy and objective individually, which is consistent with current guidance. The results from the HRA reports for the Herefordshire Local Plan (Core Strategy) were also taken into consideration.
- 2.4 None of the Eardisland NDP objectives and policies (November 2015) were concluded to be likely to have a significant effect on the European sites. This conclusion is based on assumptions and information contained within the Eardisland NDP, the Herefordshire Local Plan (Core Strategy) and the HRA for the Local Plan (Core Strategy).
- 2.5 Due to recognised flooding and environmental constraints, the NDP proposed criteria based policies for future housing, in order to facilitate some element of proportional growth envisaged by Policy RA2 of the Local Plan 9Core Strategy). Therefore there are no site allocations within the NDP. The water cycle study highlights that most of the River Wye catchment is in a moderate ecological status. The River Arrow runs through the parish and is part of the hydrological catchment of the River Wye. Therefore, the parish falls within the Upper River Wye catchment area. The River Wye downstream of the confluence with the River Lugg is currently exceeding the phosphate target. The WCS also identifies that the Eardisland Group as one of the highest areas at risk of fluvial flooding in the Upper Wye subcatchment. The Upper Wye catchment is a part of a large, linear ecosystem which acts as an important wildlife corridor, an essential migration route, and breeding area for many nationally and internationally important species.
- 2.6 It is unlikely that the Eardisland Neighbourhood Plan will have any in-combination effects with any Plans from neighbouring parish council due to the level of growth proposed overall is of the same that is proposed for the Leominster Housing Market Area in the Herefordshire Core Strategy
- 2.7 Therefore it was concluded that the **Eardisland NDP will not have a likely significant effect** on the River Wye (including the River Lugg) SAC.
- 2.8 The proposed amendments within the submission NDP have been screened to consider if they are likely to significantly affect the findings of the previous HRA Report, prepared in November 2015. A summary of the main findings is provided below.

3.1 The Submission NDP (March 2016) incorporates a number of minor wording updates and points of clarification. However, none of the policies changes their direction of travel or made changes which would be likely to significantly affect the outcomes of the previous assessment.

- 3.2 Two objectives and two policies received minor wording updates which were not of a nature to require any rescreening to be undertaken. However, rescreening has been undertaken on nine policies in total despite as these changes had added additional criteria to wider points of clarification to the policy text.
- 3.3 The revised NDP policies are therefore unlikely to result in significant effects on the European sites, a conclusion of which is based on assumptions and information contained within the Eardisland NDP, the Herefordshire Local Plan (Core Strategy) and the HRA for the Local Plan (Core Strategy).

#### 4.0 Conclusion

- 4.1 With reference to section 3 above, the additional criteria added and rewording to a number of policies are not considered to affect the findings of the previous HRA report and strengthen the likelihood of there being no adverse impacts. Moreover, the Local Plan (Core Strategy) is now adopted and will provide further policy safeguards.
- 4.2 Therefore the earlier conclusion that the **Eardisland NDP will not have a likely significant effect on the River Wye SAC** remains valid.

#### 5.0 Next steps

5.1 This Addendum Report will be published alongside both the Submission NDP and earlier HRA Report for consultation. Any changes to the plan that arise from this consultation will be subject to further screening, in order to consider their impact on protected sites.
